ROBOTICBAR Terms and Conditions for LV Casino Photobooth

Please read all these Terms and Conditions to make sure that they contain all that you want to know and nothing that you are not happy with. If you are not sure about anything, just let us know. You need to accept these Terms and Conditions in order to use the services provided by LV Casino Photobooth.

General

- These Terms and Conditions set out the rules for the use of the LV Casino Photobooth, providing the opportunity to take free photos in the LV Casino Photobooth, which is part of the Roboticbar, located in the LV Casino, for the period from 29/09/2023 until further notice.
- 2. These Terms and Conditions are made available continuously on the Website www.lvcasino.li in a manner that allows Users to obtain, reproduce and record their content.
- 3. By using LV Casino Photobooth, you agree to be bound by these T&C. You have the right and obligation to read the provisions hereof and are obliged to observe them.
- 4. We have the right to amend the current T&C, notifying You in advance by the information available in Premises/Website/Roboticbar Panel. You are responsible for checking whether the T&C are amended. By continuing to use our Services you agree to be bound by the T&C as well as by the latest modifications to it.

Glossary

The terms used in these Terms and Conditions, as defined below, mean respectively:

- 5. Premises mean gambling hall operated by LV Casino;
- 6. We or Organiser means LV Investments AG, Wirtschaftspark 2, FL-9492 Eschen, Liechtenstein;
- 7. LV Casino means the casino located at Wirschaftspark 2, FL-9492 Eschen;
- 8. <u>Terms and Conditions</u> or <u>T&C</u> these rules and regulations, setting out the terms and conditions of using the LV Casino Photobooth;
- 9. Customer means a visitor to the LV Casino located at Wirschaftspark 2, FL-9492 Eschen;
- 10. <u>User</u> or <u>You</u> means a customer who has agreed to use our Services in the LV Casino Photobooth;
- 11. Roboticbar means fully automated and contactless robot bartender designed to deliver alcoholic and non-alcoholic drinks to the Customer, which is located in LV Casino;
- 12. <u>The Roboticbar Panel</u> or <u>Panel</u> means a touchscreen panel located next to the Roboticbar in the LV Casino through which the User obtains the ability, among other things, to select alcoholic or non-alcoholic drinks from the Roboticbar, as well as to take photos of

- himself/herself, to select the photos, to accept the terms of these Terms and Conditions and consents while waiting for a drink to be prepared;
- 13. <u>LV Casino Photobooth</u> means the automated, unmanned device that takes the User's photo and has the ability to send the taken photos under the terms of these terms and conditions;
- 14. <u>Services</u> means the services related to taking photos in the photo booth while waiting for a drink to be prepared at the Roboticbar.

Participation and Use of LV Casino Photobooth

- 15. The use of the LV Casino Photobooth is voluntary and subject to the further provisions of these Terms and Conditions.
- 16. You can use LV Casino Photobooth while You are waiting for your drink to be prepared in the Roboticbar by clicking on the appropriate button which appears on the Roboticbar Panel (,, To take a quick photo clik here").
- 17. When You click on the button mentioned above, the Panel displays a preview of the special dedicated camera placed in the casino. In order to take a photo, You should press the "Start" button and then you have 10 seconds to position yourself for the photo. The photos taken will automatically be displayed on the Panel screen. The LV Casino Photobooth takes a maximum of 3 photos of the user.
- 18. Once the photos have been taken, You can choose which of the photos You want to receive and then select and accept your choice.
- 19. In order to receive the photos taken by the LV Casino Photobooth, You must first accept the Terms and Conditions by selecting the appropriate checkbox, which will be displayed on the Panel after the photos are taken, and after entering your phone number. Providing this data (phone number) is voluntary, but necessary to obtain the photo.
- 20. You may additionally agree to receive from Us marketing communications about Our new promotions and events at LV Casino via SMS to your phone number. You may also entitle Us to use, publish, and reproduce your photos for marketing or other purposes, in particular, to publish your photo on Our social networking sites. The granting of the above consents described in this provision is voluntary and their absence will not exclude the use of the LV Casino Photobooth services.
- 21. After accepting the Terms and Conditions, granting appropriate consent and providing Your phone number, You will receive a message to the provided phone number with a link to a website from which You will be able to download the photo taken.
- 22. The photo referred to above is stored under the sent link for seven (7) days unless You have consent for marketing purposes (then your phone number will be kept till you withdraw your consent). After seven (7) days, the photo is deleted from the Our system.

Liability

23. We are responsible for organising the LV Casino Photobooth in accordance with these Regulations and applicable laws.

- 24. You are liable on general terms for any damage caused by the use of the LV Casino Photobooth, which means liability for damage resulting both from damage to the photo booth itself and to the touch Panel.
- 25. While using LV Casino Photobooth You are obliged to:
 - a. Use our Services in a manner consistent with these Regulations, applicable laws and good manners, including respect for copyright or other intellectual property rights and personal rights of third parties
 - b. Not to use our Services for political or commercial purposes, including the sending of unsolicited commercial information by You.

Data protection

- 26. Personal data collected in accordance with these T&C will be processed by LV Casino in compliance with the applicable statutory data protection provisions for the purposes of using LV Casino Photobooth.
- 27. The controller of your personal data is LV Investments AG, Wirtschaftspark 2, FL-9492 Eschen, Liechtenstein, registered under the laws of Liechtenstein, you can contact our Data Protection Officer via email datenschutz@lvcasino.li.
- 28. Personal data provided by you, in particular your image and phone number, may be processed for the following purposes, depending on the scope of consents you have granted:
 - a) To enable you to use LV Casino Photobooth and send you an SMS with the link to download the photo taken – the legal basis for processing is your consent (Article 6 (1) (a) of the GDPR);
 - b) For marketing purposes, including receiving information about new promotions, events, and/ or services provided by LV Casino - the legal basis for processing will be Art. 6 (1) (a) of the GDPR;
 - c) To use, publish, and reproduce your photos for marketing or other purposes, in particular, to publish your photo on Our social networking sites the legal basis for processing will be Art. 6 (1) (a) of the GDPR.
- 29. Providing personal data is voluntary, however, is necessary to receive photos from LV Casino Photobooth. If you do not wish to provide personal data, it is not possible to use LLV Casino Photobooth.
- 30. You can withdraw your consent for processing your data for each of the purposes mentioned above at any time by sending an e-mail to datenschutz@lvcasino.li.
- 31. The photos are stored under the link sent to you for 7 days, after which they are deleted from the system unless you have consent for marketing purposes, in that case, your phone number or image will be kept till you withdraw your consent.
- 32. In order to properly provide Services, it is necessary to provide certain information to other entities related to LV Casino. In particular, LV Casino has the right to disclose required information to auditors, customer service providers, financial product providers, commercial partners, marketing and public relations service providers, operational service providers, agencies, trade services. The purpose of such disclosure is to enable LV Casino to provide You with the Services. Unless expressly stated otherwise, these entities

- may not use this information for purposes other than those for which it was made available to them under applicable laws and contracts.
- 33. You acknowledge that LV Casino has the right and obligation to disclose data and information about you to the competent authorities and administrations of Liechtenstein. By using the Services, in particular, you agree to disclose required information to the police and other law enforcement agencies, security services, authorized governmental institutions, intergovernmental institutions, market regulators and industry regulatory and other organizations.
- 34. The transfer of personal data might take place only within the framework of a separate agreement on the processing of personal data. Your personal details will not be transferred to third countries, outside EEA.
- 35. LV Casino's Privacy Policy further defines the handling of personal data that LV Casino obtains from You in connection with your use of LV Casino's services and your rights and obligations in this regard and is readily available in our Premises. Please read it before you use our services. If You use LV Casino services, you consent to the collection, use and sharing of your personal data in accordance with the Privacy Policy that complements these Terms and Conditions.
- 36. If you have reasons to believe that your rights regarding processing of personal data might be violated, you have right to send a complaint to the Data State Inspectorate according to the provisions of the Law on Personal Data Protection:
